CHAI in its 76th year continues to contribute as the largest nongovernmental healthcare-provider in the country. The core focus of the network remains **compassionate**, **affordable**, **and quality healthcare**. Several key events were organized and partnerships were formed in the past year which marked the Platinum jubilee of CHAI.

A draft document "Vision 2030" has been developed through the help of external stakeholders and experts. The document outlines a ten-year transformation vision to sustain and improve CHAI's capacity to serve the nation.

The legacy of Sr. Dr. Mary Glowrey was celebrated at the Australian High Commission Event followed by a visit to Guntur by an Australian delegation. The platinum jubilee National Health

Convention was organized in Hyderabad to celebrate, reflect on the past and discern the direction for the future. Several strategic partnerships were formed and renewed in the year including partnerships with TechCare4All, Billion Lives and University of Melbourne among others.

Expanding reach

In addition to the network reaching 21 million people annually, CHAI also implements 15 major projects across India through the Central Office in thematic areas of community health, palliative care, disability and children affected by HIV/AIDS.

During the year 2018-19, CHAI has reached out to 28,21,048 people and 5,40,576 households through awareness activities. 86,148 people were tested in the community and 23,161 were referred for medical care.

31,506 patients were reached through health services in these programs. 38,796 members were linked to various government schemes.

207 CHAI MIs, 107 Non-Governmental Organisations partnered with CHAI in reaching these people. These partners have 850 trained local volunteers engaged in grass roots work.

1,214 members underwent capacity building, which helped in honing the skills of our staff, partner organisations staff, our Sisters and various volunteers.

Future direction

The **Vision 2030** document through intensive consultations, both internal and external, will be evolved into a roadmap for optimizing CHAI's vision of "Health for All" in a sustainable manner.

We envision that this roadmap may enable CHAI to achieve by 2030 four major transformations and become:

- A more dynamic network of interdependent members
- A leader in quality healthcare in India
- A trusted source of data-enabled health information and insights in the country through its innovative digital health programs
- CHAI to be visible with outstanding reputation and attractiveness

- 158 children were given vocational trainings.

Non communicable Diseases

- 15 personnel of 5 partnering MIs were trained on cancer - screening to detect cervical and breast cancers in women.
- 47,151 people (10,592 men, 28,332 women and 8227 adolescents) were reached through 283 health literacy camps.
- 25,000 leaflets and 25,000 self-screening forms were used to create awareness on cancer
- 6464 women were tested in 251 camps for cervical and breast cancers.
- 316 women were referred to different hospitals for further diagnosis of breast cancer and 512 were referred for cervical cancer.



• 5 women were diagnosed positive for breast cancer and 2 women were for cervical cancer.

Palliative care

- 250 patients were admitted for palliative care treatment covering 3691 in-patient days in the last quarter.
- 344 patients received consultation for palliative care in the OPD.
- 402 home-care-visits were conducted.
- 68 palliative care sensitization interventions were conducted
- 5512 people were sensitized on various aspects of palliative care
- \bullet 68 patients were in ward referral from other hospital to HPCC and HPCU
- 18 patients were referred to a higher clinical facility for treatment.

Disability

- 7583 children/youth with disabilities were supported in the year.
- 4974 children were given healthcare support.
- 5217 were given education support.
- 956 were given livelihood opportunities.

• 8 Member institutions got four wheelers in order to increase the children's mobility, enhancing access to children from remote areas. This support was given by MIVA-The Netherlands through Liliane Foundation.

Eye-care programme

- 24465 persons were screened for eye-related problems.
- 3138 persons underwent Cataract surgery.
- 18745 people were made aware on common eye-problems and blinding eye-diseases.
- 257 community health workers were sensitized on disability inclusive eye health practice.
- 87 persons trained on disability-inclusive eye health.

Digital Reach programme

- 11 children underwent corrective deformity surgeries.
- 20 children got assistive aids and appliances depending on the needs.
- 140 children were visited for field-based monitoring and stakeholders were given training on functional rehabilitation skills.
- 40 Community-Based Rehabilitation Workers are transferring functional rehabilitation skills to parents and developing adaptive devices with locally available resources.
- 65 field-based videos were uploaded in "CHAI Digital Reach" YouTube channel.







Disaster Intervention

Project brief

CHAI has been working in the field of HIV/AIDS since 1993 focusing on equipping and enabling its members to work for people infected and affected by HIV/AIDS. Over the years, through various programmes, CHAI has enabled its Member Institutions to manage HIV/AIDS centres in counselling, clinical management, care and support.

The project "Swalambhan- Empowering Children Affected/Infected By HIV/AIDS (CABA) through Formation, Linkages and Sponsorship Services in India" aims at enhancing the quality of life of these children under the following broad intervention strategies:

- Linkages with different medical and social support systems
- Sponsorship generation
- Empowerment through life-skill education

Accomplishments

Linkages

- Among the infected children, 506 were receiving institution-based care and 497 home-based care. 98% of these were linked to Antiretroviral therapy (ART) centers. 205 children were referred to other organizations for co-infections (Medical) and 104 children for rehabilitative support.
- 121 children were linked with Social Security schemes.
- 484 children were enrolled in schools for primary and higher education
- 259 children participated in child-group parliaments

Sponsorship

• 89 sponsors provided cash or in-kind support to the children

Empowerment

- 9 project coordinators were trained on local resource mobilization
- 33 peer leaders and 6 counsellors were trained on life-skill education. The peer leaders in-turn are orienting their peers at institutions.
- 158 children were given vocational training on various trades (shoe-making, tailoring, computer, mushroom cultivation, candles making, washing powder-making, bag-making, wall-painting and Karate) for fostering entrepreneurship.

The families will also be given hands-on-training to care patients and at the same time they will be given counselling to help deal with their situation. The goal of the project is to assist the patient to live the last days in dignity and with peace. Capacity-building and trainings are planned to ensure that care-providers, counsellors are well-versed to have the knowledge and skills to treat palliative care patients. Resource- mobilization is key component leading to sustainability of intervention. • 250 patients were admitted for palliative care treatment, covering 3691 inpatient days. Accomplishments • 344 patients received consultation for palliative care as outpatients. • 402 home-care-visits were conducted. • 68 palliative care sensitisation interventions were conducted. • 5512 people were sensitised on various aspects of palliative care. • 68 patients were referred to Pratyasha palliative care centre from other hospitals. • 18 patients were referred to a higher clinical facility for treatment.

"Serving the Nation in Reaching the Unreached – 75 Years and Beyond"


Introduction

The Platinum Jubilee Celebration and National Health Convention 2018 of Catholic Health Association of India (CHAI) was celebrated with great enthusiasm and exuberance on September 28-29, 2018, at the CHAI Training Centre, Medchal, Hyerabad. The theme for the event was "Serving the Nation in Reaching the Unreached – 75 Years and Beyond". Around 500 delegates from across the country attended the two-day programme.

CHAI has been committed to the motto of 'Bringing Healthcare for All' for

the past 75 years and has reached thousands of people, inspired by the vision of the founder, Sr. Dr. Mary Glowrey. The Jubilee was an occasion to celebrate, reflect on the past and discern the direction for the future.

The celebration included a host of exciting events – the Holy Eucharist, Inaugural Function with key allies, and inspiring input sessions, Business Session, a rocking Cultural Evening and a session to honour past Presidents & Directors.



Day 1

The programme started with Mass by His Grace Most Rev. Prakash Mallavarappu, the Archbishop of Visakhapatnam & the Ecclesiastical Adviser of CHAI. Bishop Most Rev. Peter Remigius, Bishop of Kottar, Rev. Dr Mathew Abraham, Director-General of CHAI and more than 20 priests concelebrated.

Immediately after the Mass, the delegates gathered outside the hall, and in the presence of all, Archbishop Mallavarappu hoisted the CHAI flag.

INAUGURAL FUNCTION

The inaugural ceremony started with a welcome address by Sr. Deena, President of CHAI. She congratulated all the members on the occasion of the Jubilee and highlighted the importance of self-introspection in order to discern the future direction. After the welcome, all the dignitaries were invited on stage to light the ceremonial lamp.

HIGHLIGHTS AND RELEASES

The next section was focused on

the Highlights and Releases of the past year for CHAI. Rev. Dr. Mathew Abraham, Director-General, gave an overview of the highlights of the AGBM and what to expect over the following two days. He also expressed his gratitude to all the representatives from all over the country who participated in the event. He mentioned about the other events that were part of the Jubilee celebration i.e., the National Reflection in February 2018 at St. John's Bengaluru, the CHAI day celebrations on 29th July 2018 and the forthcoming event in partnership with the Australian High Commission (AHC).

He narrated the story of the founders of CHAI - 16 courageous religious women and reiterated his commitment to continue serving in the healing ministry.

The next segment was the launch of publications and new initiatives of CHAI. The Annual Report 2017-18 was launched by Most. Rev. Prakash Mallavarapu, Ecclesiastical Advisor – CHAI, followed by release of the Platinum Jubilee Souvenir by Ms. Anuvinda Varkey, Executive Director, CCHI. She commended all CHAI members and partners for their contribution to the souvenir.

Dr. Sara Varughese, National Director and Managing Trustee, CBM gave a message highlighting the dedicated staff in the network and appreciating the accessible and affordable health services being provided by CHAI for the needy. She mentioned the importance of research, training and capacity enhancement.

Sr. Dr. Beena, President, Sister
Doctors Form of India (SDFI) launched
CHAI's Services portal for common
procurement and congratulated the
organization on its Jubilee. This was
followed by Dr. Sunil Gokavi, Executive
Director, Emmanuel Health Association
(EHA) acknowledging the Christian
network as the second largest in India
in the field of healthcare. He focused
on the impact that can be created in the
current health scenario with such a vast
network.

The CHAI Herbal Calendar 2019 was released by Dr. Ermanno Pavesi, Treasurer, World Federation of Catholic Medical Associations (FIAMC) and after this, Dr. Bimal Charles, General Secretary, CMAI, spoke about the importance of primary health care in India and how its' significance is being diluted by medical professionals.

Dr. Piet Reijer, Public Health
Consultant, Medical Mission Institute,
relaunched the CHAI website. He
appreciated the efforts to revamp the
website, particularly the aspect of
incorporating fundraising options. Sr.
Sarla Macwan, President, Catholic
Nurses Guild of India (CNGI), expressed
her gratitude to the members of CHAI
for working in far flung areas and
providing health care services to those
most in need.

Mr. Henk Hofste, Head – International Partnerships & Programs, Liliane Foundation (LF) launched the first fundraising campaign. He then announced that it is a tradition with LF to provide a gift to partners celebrating a Jubilee. On behalf of LF, he presented to Rev. Dr. Mathew Euro 50000 towards an Award to be instituted by CHAI to showcase work done in Disability in India. Fr. Mathew received the Award with gratitude on behalf of CHAI and all its members.

Subsequently, Fr. Mathew Perumpil, Health Secretary, CBCI, gave an update on the CHAI Strategic Planning Process. After the highlights & releases, Sr. Thomasamma, President, CHAI - AP & Telangana, gave the Vote of Thanks, appreciating all the dignitaries for their presence and encouraging words. CHAI Mementoes were also handed over to the dignitaries for joining CHAI in its celebration.

This segment was concluded with the CHAI anthem.

SPEAKER SESSION

This session included the experience sharing of inspiring and courageous people in the Healthcare sector.

Mr. Kamal Shah, Co-founder and Director – Nephroplus talked about his experience of living an active, normal life while being on dialysis for the past 21 years. He explained how this inspired him to start Nephroplus, one of the largest dialysis care networks in India and how this is helping several people become more independent and confident.

Mr. John Santhosh, Director - Billion Lives, shared his experiences of raising and disbursing funds for social impact. He explained how he plans to use technology to reach a billion lives. He acknowledged CHAI's capacity in



reaching out to huge numbers and is committed to working with CHAI to bring the benefit of technology.

Ms. Minnie Mathews, IAS officer, Chief Secretary to the Government of Andhra Pradesh (Retd.) spoke about the importance of reaching the unreached. She shared her experiences in the government and as a woman in a man's world, identifying with the Sisters who work in remote places and difficult situations, and are able to bring about great change.



Dr. Taru Jindal, Associate Director,
Reproductive and Child Health Doctors for you, shared her experiences
that were adventurous and inspiring.
Born and brought up in Mumbai, she
moved to work in a rural part of Bihar
were healthcare facilities are either
non-existent or even dangerous.
Through her service, she played a key
role in transforming those primary
health centres to model hospitals in
the area. She affirmed that change
is possible with togetherness and
persistence.



Prof. PK Thomas, Co-founder and Managing Director- Mentor Max Incubation Services, highlighted the importance of technology to provide health care in remote areas where doctors are scarce. With education reaping the benefits of technology, he explained that healthcare also can use electronic gadgets to get vital details of the patient, diagnose and provide prescriptions.

After lunch, the regional reports were presented as a video compiled

with the activities, achievements and highlights of each region (CHAAP, CHABIJAN, CHAKA, CHAKE, CHAMP, CHAT, CHAW, NECHA, OCHA, RUPCHA, WBCHA). After the presentation, the representatives of each region were available for comments and questions from the audience.

Mr. Sarat Chandra, Consultant, Vitamin Angels shared about the work their organisation is doing to combat the devastating effects of vitamin A deficiency and the continuing relationship with CHAI and its Member Institutions.

Dr. Piet Reijer & Ms. Sieglinde Mauder from Medical Mission Institute demonstrated MEDBOX, an openaccess library aiming to increase the quality of health care across the globe. It has collected more than 14,200 documents in nearly 800 different sections available in various languages. This is available for the CHAI network to access and use.

BUSINESS SESSION

The Business session was chaired by Sr. Deena V.J. SCN, President of CHAI. After the introductory remark by Sr. Deena, Rev. Fr. Santhosh Dias, Secretary, CHAI, read the minutes of the 74th AGBM.

The minutes were passed by the General Body. Once the minutes were passed, Rev. Dr. Mathew Abraham presented the Annual Report of CHAI for the year 2017-2018. He went through the main points of the Report, highlighting project achievements and the new initiatives of CHAI.

Sr. Sneha, Treasurer, CHAI, then presented the statement of accounts for the year 2017-2018 & budget for the year 2018 - 2019.

Appointment of auditor was done by the General Body. The President proposed that the same auditors, Leo Amal Raj & Associates, may be re-appointed as auditors for the financial year 2018-2019 and the house unanimously agreed to re-appoint M/s. 





- **1. Basis of preparation of financial statements:** The financial statements are prepared in accordance with the generally accepted accounting principles in India and in accordance with the historical cost conventions.

- **7. Retirement Benefits:** Retirement benefits to employees are not provided in the accounts and the same are accounted as and when the payments are made.
- **8. Contingent Liabilities:** No contingent liabilities have come to the notice of the management.
- **9. Confirmation of Balances:** The confirmations of balances have not been obtained in the case of debtors and creditors of the society.
- 10. Previous year's figures have been re -grouped wherever necessary.
