## **Executive Summary**

It is with great pleasure and immense gratitude that I present the Annual Report from the CHAI Directorate for the financial year 2023-24, at the 81st Annual General Body Meeting (AGBM) of CHAI. In line with our Vision 2030, CHAI continues to strive towards 'compassionate, affordable and quality care for all, especially those at the margins of the society. In the context of various external and internal challenges faced by the Member institutions of CHAI, The theme chosen for this year's AGBM is "Long-Term Sustainability of Healthcare Mission". This theme needs to be looked under three important areas: Sustainability of Mission & Ministry, Financial Sustainability, & Self-sustainability of those who are giving leadership.

#### A Snapshot of CHAI Directorate Projects

In the last financial year 2023-24, the Directorate continued to implement projects focusing on our core areas. These include Community Health, which aims to improve the overall health and well-being of village communities through comprehensive primary healthcare approach. Through Palliative Care initiatives, we provide compassionate care to individuals with terminal illness and their families, helping them to go through dignified and painless transition from this life. For individuals with disabilities and children affected by HIV/AIDS, specialized programs are in place to support their unique needs and ensure they receive the necessary care and resources.

In addition, the Directorate is actively working on decarbonizing healthcare, aiming to reduce the negative impact of healthcare activities on the environment. CHAI Directorate also organized several capacity building workshops and training programs to enhance the management / leadership skills of those giving leadership in the healthcare institutions and community health skills for those who are giving leadership at the community level.

#### Key Highlights

During the financial year 2023-2024, approximately 1.1 million people were reached through various projects supported by CHAI Directorate. This was achieved in partnership with 273 Member Institutions (MIs). The key achievements include:

- 243,247 people reached through health education and awareness campaigns
- 619,403 people benefited through treatment services
- 243,247 referral services facilitated
- 35,451 telehealth services provided
- A total of 1,141,631 beneficiaries were reached

Healthcare is an area that needs ongoing innovation. In line with Vision 2030, CHAI aspires to establish itself as a prominent and dependable healthcare provider. To fully harness the potential of the network, CHAI collaborates with Catholic Relief Services (CRS). This collaboration named as 'Advance Local Leadership in the Right Way' (ALLRight), strives towards developing a robust Monitoring, Evaluation, Accountability, Learning (MEAL) system for CHAI directorate; and a mechanism for generating real-time data collection, aggregation, trend analysis, and impact measurement for the CHAI network.

#### **Way Forward**

CHAI will continue to focus on its core areas: Community Health, Palliative care, Disability care, and Children with HIV. In addition, CHAI will continue to work towards, environmental sustainability, and long-term sustainability of the healthcare mission, including leadership building, especially women leadership. CHAI will continue to strive for strategic collaborations and networking. By pursuing these strategies, CHAI aspires to work towards building a sustainable and resilient healthcare network that provides compassionate, affordable, ethical, equitable, and quality healthcare services for all, especially those at the margins of the society.

I would like to conclude by expressing my sincere gratitude to the CHAI team at the Directorate, funding partners, our Member Institutions, Regional Units, and the Governing Board. Without their support these achievements were not possible. Despite the challenges that lie ahead, we remain optimistic that the CHAI health network will continue to make a difference in the lives of millions of people, who cannot afford the highly commercialized healthcare services. As in the past, in our journey with those who are sick and suffering we will continue to experience the hidden presence of God as our guide and comforter, and the communion of saints, especially that of our founder, Sr. Dr. Mary Glowery.

# Program Report 2023-24

## 1 Community Health Project





Enhancing Collaborations with the Government and other Agencies & Scale up Services of Community Health Interventions in 8 RUs/Partner Organizations of CHAI - RUPCHA, CHAAP, CHAMP, CHAT, OCHA, CHABIJAN, Karnataka and Maharashtra implemented by 35 MIs with target groups being vulnerable and marginalized people in rural areas with a special emphasis on women and children.

#### **Objectives**

Cooperation between government agencies, other agencies in the public health sector and CHAI Member Institutes (MIs) across 15 states has improved.

The population of 175 villages is empowered in safeguarding their health, through the work of 35 CHAI MIs. The response to COVID-19 is strengthened by a provision of immediate and long-term support to affected families by establishing a telehealth model and through using real-time electronic data.

#### **Collaborations**

- 1. Facilitated 41 MoUs between CHAI Member Institutions and other organizations with an approximate outlay being close to Rs. 3 crores.
- 2. Networking Meetings were organized by the RUs/POs at Ranchi, Bhopal, Delhi, Nagpur, Bangalore and Vijayawada to facilitate collaboration and partnership. The meetings assembled representatives from the Government (NHM, SACS, TB, RMNCH+A) CSR, INGOs, NGOs and RUs and MIs of CHAI.

## 2 Empowering Children Affected/ Infected By HIV/AIDS (CABA)







This project is funded by Misereor – Germany implemented by 10 Member Institutions (MIs) of CHAI in 5 states of India - Bihar, Jharkhand, Tamil Nadu, Telangana, and Andhra Pradesh.

The objectives of the project are:

- 1,500 HIV/AIDS-infected and affected children from ten target areas have access to holistic medical treatment, social care and government support.
- 900 children/adolescents with HIV/AIDS are strengthened in their life skills and have significantly better prospects for the future.
- The negative consequences of the COVID-19 pandemic have been mitigated for the target groups.

The project aims at enhancing the quality of life of the children by linking them to medical and social support services including ART treatment, education, skill development, socio-economic support and psychological support.

## **3** Tuberculosis project (Axshya Plus)








Funded by The Global Fund to Fight AIDS, Tuberculosis and Malaria (GFATM) is being implemented by The International Union Against Tuberculosis and Lung Disease (The Union) in Maharashtra (33 districts) and Jharkhand (11 districts) with the target population being Asymptomatic Household Contacts of Pulmonary Index TB Patients.

Project Axshya Plus is an aspirational initiative to broaden the scope and impact of the TB intervention Program in India to unprecedented levels. CHAI as a sub recipient of The Global Fund grant through PR, The Union for Project Axshya Plus has rolled out the Programmatic Management of TB Preventive Therapy for the National TB Elimination Programme (NTEP) and the Central TB Division (CTD).

The project maintained an excellent quality of the programme at district and state level in Maharashtra and Jharkhand. Axshya Plus teams were actively involved in providing support for capacity building of the NTEP field staff, Nikshay Portal entries and TPT drug management.

The objectives of the project are:

- 1. To demonstrate implementation models, generate evidence, and scale up programmatic management of TB preventive treatment.
- 2. Mobilize resources and resourcefulness of various stakeholders through multi-sectoral convergent actions.
- 3. Promote Operational Research to generate evidence for policy decision making by the National Programme.





## 4 Disability Inclusive Eye Health Program





Disability Inclusive Eye Health Programme is funded by Christoffel-Blinden Mission (CBM) implemented by Jeevan Jyothi Hospital, Jhabua - Madhya Pradesh, Samaritan Hospital - Satna, Madhya Pradesh Mary Ward Health Centre, Buxar - Bihar and Varanasi Medical Society - Varanasi, Uttar Pradesh. The project aims to provide free cataract surgeries to the marginalized people and works towards developing the capacity of implementing member hospitals to undertake disability inclusive eye program in the communities.

## 5 Empowering Children with Intellectual Disability (NAVDARSHAN)



It is funded by V Guard Industries Ltd and works towards empowering children with Intellectual disabilities in Telangana State and symbolizing a commitment to holistic development for the differently abled. This program is being implemented by 3 Member Institutions through 10 Special schools providing quality Special Education, Therapeutic Support, Vocational Training and Capacity Assessments. This program reached 1000 children who have Intellectual disabilities.

## 6 Government School Support Program

Funded by V Guard Industries Ltd implemented in 6 Government schools in Cherlapally Municipality to develop facilities for safe drinking water and to promote safe hygiene practices for girls in the schools and also create a conducive environment that fosters Holistic well-being among students, thereby positively impacting their academic achievements and future prospects.

The major accomplishments were:

- R.O Water filter and Water Cooler Installed in the targeted schools
- Sanitary Pads Vending Machine and Sanitary incinerator installed in the targeted schools
- Furniture (Science Table) for Lab work installed in the targeted school &
- Water Dispenser and Water Cans Installed in the targeted school.



## 7 Palliative Care Program (PRATYASHA)



PRATYASHA is the program funded by MISEREOR. This program is implemented in 11 states namely, Chhattisgarh, Tamilnadu, Andhra Pradesh, Telangana, Jharkhand, Madhya Pradesh, Karnataka, Kerala, Maharashtra, West Bengal and Gujarat with target groups being Patients at End of Life stage, Patients with Terminal Illness but not at End of Life and Patients with Non Terminal Illness but needing Palliative Care via 11 Member Institutions and 20 Sister Doctors.

The objectives of this project are:

1. Approximately 2160 inpatients with terminal illnesses from 11 regions of India receive rational, affordable and quality end-of-life palliative care services.

- 2. About 9540 patients as well as their family members receive holistic medical, psycho-social and spiritual care and support in their family environment (home-based), with the involvement of the respective community
- 3. Sister Doctors and Sister Nurses from 10 CHAI member institutions are empowered to provide holistic palliative care (HPC) to patients and their family members in hospital as well as home surroundings.
- 4. Efforts to enhance networking and dialogue to strengthen palliative care locally and beyond have been promoted.



## 8 Promoting Women Leadership: Enabling Indian Catholic Sisters



The project focuses on the overarching goal of enabling Indian Sisters to transform the lives of the underserved and disadvantaged. This includes majorly enhancing the capacity of 200 sisters in management and leadership and 200 sisters as community health enablers. Strengthening 47 healthcare facilities to deliver enhanced health service to the underservice marginal section of the society.

The components (Community Health, Disability & Palliative Care) and Training Programs for Sisters (Leadership & Management and Community Health) are funded by Conrad N. HILTON Foundation and Hilton Fund for Sisters.

These 3 components are implemented by 47 Member Institutions across different states in India. Community Health Support is provided through 16 Mi's with the target population being Vulnerable children & Women, ANC/PNC, Elderly people, Pregnant women & children. For Disability it is through 13 MI's supporting via livelihood, purchase of assistive devices and rehabilitation therapy for the children & adults with special needs. Palliative Care is implemented through 18 MI's.

With regard to the capacity enhancement program, following are the sisters trained:




## 9 Decarbonizing Healthcare



The 3-year project aimed to decarbonize health-care, enhancing service delivery while reducing emissions. It led to the solarization of 26 health facilities spanning 3 states and 19 districts. Among these districts, 8 were classified as aspirational districts. The health institutions were powered with a total solar PV capacity of 238 kWp. The consumption of electricity from these solar PV installations resulted in combined cost savings exceeding INR 7,06,364 and has avoided emissions of 75t CO2 that would have been

sourced from the diesel generators and the grid. Over 432,435 people accessed these facilities for medical care and treatment with health services powered by solar PV. This integrated approach to health (SDG3) and Energy (SDG 7), enabled us to provide green and reliable source of power to our healthcare network which in turn supports decarbonization efforts while enhancing healthcare services, enabling upgrades, and expanding access.

## **10** Advancing Local Leadership in RIGHT Way (ALLRight)



CHAI aspires to establish itself as a prominent and dependable healthcare provider driven by data as outlined in its long-term 2030 vision document. The fundamental challenge at CHAI Directorate revolves around our inability to fully harness the potential of the network in pursuit of this vision.

CRS (Catholic Relief Services) donors of the ALL-Right Fund, works with organizations around the world, that help poor and vulnerable people overcome emergencies, earn a living and access affordable health care. Following short-term COVID response projects, CHAI and CRS were naturally drawn to each other due to their shared vision and core principles.


In January of 2023, using HOCAI (Holistic Organizational Capacity Assessment Instrument) assessment tool of CRS, CHAI explored potential challenges of insufficient capacities, systems, and procedures related to generating knowledge and making data-driven decisions. Organizational learning & Programming, Services and Results emerged as key components towards network

strengthening and sustainability and CHAI's efforts are to advance the three key facilitators for transformation-

- building capacities at Directorate staff,
- introducing tools to gather and store knowledge and data, & network strengthening,
- to improve processes for gathering and utilizing health-related information.

Both the teams engaged in a process that included problem tree analysis, theory of change development, and the creation of a results framework & log frame as a part of the project proposal design. Goal- The CHAI Directorate is leveraging the full potential of the network to realise its Vision 2030 towards affordable, compassionate and quality healthcare services.

Specific Objective - CHAI Directorate is capacitated with MEAL policies, system, processes and human resources towards generating learning and data led decision-making.



#### **Activities done**

- Project Steering Committee (PSC): with members from the leadership/management of CHAI and CRS was established to guide and support change management. PSC has met twice i.e. on 15th Sep'23 & 18th Jan 2024 to identify challenges and opportunities and extend support.
- Sub-Recipient Financial Monitoring Policy Assessment: SRFM was conducted by CRS team in Jun'23, to check transparency and accountability in the financial management. CHAI's overall score was 85%, and with an aim for 90% score, the assessors offered an improvement plan.
- Partner Safeguarding Policy (PSP) Assessment: In order to adhere to global safeguarding standard of creating safe and ethical environment, CHAI is committed to developing a well structured and globally aligned policy. The policy has been resubmitted for CRS vetting after making necessary additions and amends.
- Feedback Complaint Response Mechanism & Learning question workshop: A common FCRM pathway is developed for Directorate and Network which stems on existing feedback and complaints channels. It is under review of CHAI SMT and will be rolled out once approved.

For ongoing institutional strengthening, while focusing on creating a culture of learning, CHAI and CRS came up with the learning question which will help us track the direction of project

• Conducting baseline assessment of existing MEAL capacities of Directorate and Network staff: Key Informant Interviews (KII) were done with 5 Program Managers of CHAI in Feb-Mar'24. As they are managing different donor driven projects under 4 thematic area (CHP, Palliative care, CABA and Disability), which are implemented through the Member Institutes, (sometimes Regional Units), they are primary respondents to inform on the existing system and processes (as data source, data flow or data templates). These Program Managers are keepers of CHAI's data and have fair knowledge of the existing MEAL capacities and appetite for change in the network.

The follow up plan includes insights gleaned from the KII transcripts from Directorate, enlisting broad area of questioning for the Network staff at RUs and MIs (in course with baseline assessment of MIs). This data derived will support development of a road map for designing MEAL policy and processes at the Directorate level and also will guide us in engaging the network in more effective and efficient ways.

## **11** Supply of Medicines and Health Consumables



A CSR activity funded by Fernandez Foundation in 15 Member Institutions of CHAI in 8 States including Maharashtra, Karnataka, Jharkhand, Madhya Pradesh Tamil Nadu, Bihar, Meghalaya and Telangana. This project aims to support individuals and families from very poor economic backgrounds by providing medications, aids, appliances and essential supplies. These beneficiaries face challenges in accessing these necessities due to their remote locations and extreme poverty. The project aims to reduce illness and enhance mobility among communities located in difficult-to-reach geographical areas.

8 MIs received essential consumables such as bandages, dressings, syringes, needles, gloves, masks and disinfectants. They also received diagnostic tools including thermometers, blood pressure monitors, glucose meters. Additionally, medications such as antibiotics, anti-malarials, oral rehydration salts, analgesics, multi vitamins, calcium supplements and medications for chronic conditions like diabetes and hypertension were provided to treat patients at their health centers.

- 1710 patients benefited through medicines and surgeries
- 300 children infected and affected with HIV/ AIDS provided with food kits comprising of dry rations to fulfil their nutritional needs.
- 100 aids and appliances including walkers, wheel chairs, CP Chair, Tri cycle, Rollator were provided to individuals with disabilities to improve in terms of mobility, communication and for performing their daily activities.

## **12** MGLB Disability Award 2023



Funded by Liliane Foundation for Organizations dedicated to serving people with disabilities across India. The main objectives are:

- To acknowledge and encourage exemplary efforts by organizations and individuals in the disability sector
- To honour the resilience of individuals living with disabilities.

On the occasion of CHAI's Platinum Jubilee in 2018, Liliane Foundation announced its support for 'Mary Glowrey - Liliane Brekelmans Disability Award'. This award was instituted as a token of appreciation for CHAI's services to individuals living with disabilities. Since then, Awards have been given to individuals and organizations demonstrating exceptional dedication to improving the

lives of people with disabilities. The awards were given in the following three categories in 2023:


- 1. A Role Model NGO/Institution
- 2. A Role Model person with/without a Disability
- 3. Commendation Prizes

Nominations were invited via the website www. chaiawards.org resulting in over 43 entries received nationwide across both organizational and individual categories. A prize amount of Rs.8 lakhs 20 thousand was awarded among the given categories. Additionally, 8 commendation prizes were awarded to individuals and organizations.

## **13** International Students Exposure Program



This project is funded by Australia Catholic University, Melbourne, Australia. It involves students from Nursing and Midwifery as well as Occupational & Speech Course. These students from Australian Catholic University (ACU) had an exposure visit aimed to gain an insight into the Indian community health practices and treatment procedures under supervision in Telangana state.



# Other Activities

## REPORT OF THE 80<sup>th</sup> ANNUAL GENERAL BODY MEETING (AGBM)

Theme: Leadership for Sustainable Healthcare



The CHAI National Health Convention and 80th Annual General Body Meeting (AGBM) was held on September 21-22, 2023, at Don Bosco Institute, Guwahati, Assam. This was the first Hybrid AGBM of CHAI, and was attended by 154 participants onsite, and about 200 online, from the 11 regional units of CHAI. The overall theme was "Leadership for Sustainable Healthcare".

#### DAY 1: **SEPTEMBER 21, 2023**

The first day of the programme commenced with the inaugural Mass at 7.00 am by Bishop Lumen Monteiro, Ecclesiastical Advisor, CHAI. Soon after the Mass, the delegates gathered outside the hall and in the presence of everyone, Sr Victoria Narichiti, President of CHAI hoisted CHAI flag.









The inaugural session started by 9 am by Sr. Victoria Narichiti JMJ, President of CHAI welcoming the participants. Emphasizing the mission of CHAI in her address, she reiterated that CHAI healthcare facilities continue to provide affordable, quality, and compassionate health services to the needy and marginalized in our society, despite facing several challenges. She concluded her welcome address by remembering Sr. Mary Glowrey, a servant of God, and encouraged everyone to let her life be an inspiration for all the member institutions. It was then followed by the lighting of the lamp by the dignitaries.

Fr. Cletus Sebastian SDB, Executive Director of DBI welcomed the participants to DBI overlooking the panoramic view of the mighty Brahmaputra River and gave an overview of the institution.

After the inaugural ceremony the thematic sessions were started which was more of a 'story telling' by those who were closely associated with the CHAI directorate. It began with an introductory note by Fr. Mathew Abraham, C.Ss.R., the Director General of CHAI.

#### Thematic session 1: CHAI Impact Hub

This was followed by a session on 'CHAI Impact Hub' by Mr. John Santhosh, who shared about various sustainability initiatives of CHAI directorate.

He explained the QR code system for CHAI's member institutions and its usage within the Impact Hub, allowing them to enlist in the healthcare service network, which can also enhance CHAI's visibility. At the end of this session, Impact Hub was officially inaugurated by Bishop Lumen Monteiro, the Bishop of Agartala and the Ecclesiastical Advisor of CHAI.

#### Thematic session 2: Partnering for Sustainability

Mr. Srivathsan Aparajithan and Sr. Dr. Annie Sheela, CTC, shared about 'collaboration for sustainability'. He explained the present-day realities of CHAI members who have been providing health-care services for over 100 years. New strategies have been devised to sustain these institutions by outsourcing hospitals and laboratories. Sr. Dr. Annie Sheela shared the challenges faced by her hospital management, such as meeting the infrastructure standards required for MBBS, doctors being unwilling to work due to lower salaries, and the need for empanelment in government schemes like AB-PMJAY and ESI. Thus, partnering for sustainability was the way forward to overcome these challenges.

#### Thematic session 3: Financial Sustainability

Mr. Allen Andrade CA, talked about "Financial Sustainability". He has over 35 years' experience with Finance & Strategy for large, international companies in oil & gas, entertainment, banking & FMCG. His experience covers a wide range of expertise in startups, restructuring, established, and joint venture operations involving international companies' interests in India. Drawing upon his expertise, Mr. Allen Andrade shed light on some crucial areas to achieve financial sustainability in alignment with the current scenario. He emphasized the technical requirements necessary to meet the criteria for sustainability.

## Thematic session 4: CHAI Telehealth - Supporting Health Centres in Remote Areas

Mr. Jean Toms, Telehealth Project Coordinator, CHAI, facilitated a discussion on 'CHAI Telehealth initiative' highlighting the support provided for the health centres in rural and tribal areas.

The resource person was joined by Sr. Dr. Lija Jose, Consultant Radiologist at PS Mission Hospital, Ernakulam; Sr. Siriapushpam, President of CHAT; and Sr. Ann Paul, SCV, In-charge of St. Vincent Health & Wellness Centre, West Garo Hills, Meghalaya. The Telehealth project initiative of CHAI was launched during the COVID-19 pandemic. The project, which includes three full-time doctors and visiting doctors, along with 386 member institutions, has reached out to 19,237 people in 2023. Sisters from different regions shared their journey of providing telehealth services to people in rural areas. Despite internet connectivity challenges, they were able to deliver medicines and consultations to the patients.

#### Thematic Session 5: Insights for Sustainability

Mr. Srivathsan then joined Sr. Lizy Jose SAL, Councillor of St. Ann's of Luzern to share 'Insights for Sustainability,' emphasizing the importance of making sense of existing data.

Sr. Lizy Jose shared their experience with a hospital that was experiencing a decline in spite of providing services to a significant number of patients. Consequently, they sought external expertise to analyze the hospital's data, which revealed areas of failure. This timely intervention allowed them to make informed decisions for improvement and sustainability. In his concluding remarks, Mr. Srivathsan emphasized the need to adopt tools and skills from the corporate world to work in a more professional manner for sustainability.















## Mother Giovanna Memorial Award & Cultural Evening

CHAI and Holy Family Hospital, Mumbai joined together instituted a special award titled "Sr Dr Giovanna Alberoni Memorial Award". This award recognizes the work done by Sister-Doctor in CHAI network hospitals, who have served rural or marginalized populations and dedicated their lives towards improving healthcare for a period of at least 10 years. The award consists of a citation and a cash prize of one lakh and it was presented to Sr. Dr. Regina Kotackal FC for her exemplary leadership in healthcare.

The award was presented during a cultural evening where young artists performed traditional dances from various states of North East. The cultural program featured folk dances performed by the students of DBI. The Northeast boasts a rich cultural heritage with a wide range of traditional dances, likely having the highest variety of folk dances that reflect the tribal and traditional aspects of the region. The students presented their cultural dances while dressed in their respective colorful ethnic and traditional attire. Among the cultural dances performed were Assamese Bihu, Bodo - Bagurumba, Jhumur, Rabha - Dhabai, Naga, Nepali, Mizo, Arunachali, Garo, Khasi, Manipuri, and Tripuri.

#### DAY 2: **SEPTEMBER 22, 2023**

The second day's programme began with a Holy Mass celebrated by Most Rev Dr Albert Hemrom, Bishop of Dibrugarh. Healing Ministry was part and parcel of Jesus' ministry," said Bishop Albert Hemrom. He appreciated the noble service the sisters are providing through CHAI. He insisted that we need to continue reaching the

unreached people and places in order to experience the healing touch of Jesus. He also said, "We are the ambassadors for Christ's healing.

## Thematic Session 6: Long-term Sustainability of Hospitals - Models from US and Australia

The sixth session focused on the Long-term Sustainability of Hospitals, featuring models from the US and Australia, by Ms. Rosemary Thomas, consultant CHAI. She shared on the social and professional context, emphasizing the challenges faced by the Catholic Network, such as a decreasing number of vocations, a shortage of human resources, managing multiple roles, firefighting, awareness and skills development, and resistance to change. The session also explored a potential two-pronged approach to address vocation and future sustainability.

During her presentation on new strategies for promoting vocations and ensuring the future sustainability of religious congregations and highlighted the transformative potential of the Ministerial Public Juridic Person (MPJP), which is already implemented in countries like the US, Australia, Canada, and Ireland. She shared information about the objectives, role, history, and the process of the MPJP, which grants collaborators management and ownership authority based on their understanding. This arrangement paves the way for lay individuals to assume leadership roles, enabling congregation members to ascend to higher positions while preserving the Catholic institution's charism and ministry.

## Thematic Session 7: **Providence India - Extending the Global Mission with CHAI**

The seventh thematic session of day two was on "Providence India: Extending the Global Mission with CHAI." The resource persons for this session were Mr. Murali Krishna K., Chief Global Officer and Country Head of Providence India, Roopa Rangaprasad, Director of Product Management at Providence India, and Sr. Rani Paulose, Senior Manager at Providence India.

Murali Krishna gave an introduction through a video presentation about Providence and spoke about the innovative engineering efforts at Providence India, which support digital transformation in healthcare, enhance health systems, improve patient and clinician experiences, and deliver digitally enhanced outcomes. He mentioned that at Providence India, a tech-led health system includes 30% women.











Roopa Rangaprasad spoke about technology and innovation for a new health system to provide better care and create value. Sr. Rani Paulose shared her experience at Providence Global Centre and spoke about the importance of branding. Along with the digital care system, it is equally important to be familiar with the local context when working in rural India and reaching out to the grassroots.





## Thematic Session 8: CHAI Vision 2030 and ALLRight Initiative Launch

The eighth thematic session of the day was on "CHAI Vision 2030" and the "ALLRight Initiative launch" by Senthil Kumar Gurunathan, the Executive Director of Catholic Relief Services. He stated that both CRS and CHAI, with 80 years of service, have come together to share their experiences and vision documents for a transformative change in their organizations. He also emphasized the importance of prioritizing data systems and conducting holistic assessments. During the session, the "ALLRight" project's MEAL (Monitoring, Evaluation, Accounting, Learning) was launched, and the book on "Vision 2030" was released.

#### Thematic Session 9: Spirituality of Leadership

The ninth thematic session of the day focused on the "Spirituality of Leadership" and was presented by Fr. Mathew Abraham C.Ss.R, the Director General of CHAI. He shared his inspirational life journey, evolving from religiosity to spirituality, and moving from a state of fear and guilt to one of love and inner freedom. He mentioned the significant milestones in his career choices, highlighting that his

decision to prioritize social impact over financial gain was a conscious and mission-driven choice he made at the age of 22.

When speaking about courage, Fr. Mathew emphasized that true courage is the ability to openly acknowledge one's vulnerabilities and limitations. He explained that authentic connections are formed when individuals can share both their successes and challenges. In conclusion, he stressed the importance of good leadership within the institutional church, underlining the need for such leadership to address the challenges and opportunities of the present and future.

## Messages from Well-wishes and Network Partners

Most of the messages were video messages and some of them were in-person. These messages were interspaced between the thematic sessions, over the two days.

Archbishop Anthony Cardinal Poola, Archbishop of Hyderabad in his message said that the achievements of CHAI over the years are truly exemplary and encouraged CHAI to continue to work as the vision of the organization and strive for excellence bringing a healthier future for all, inspired by faith, driven by innovation and powered by humanity.

Archbishop John Moolachira, Archbishop of Guwahati appreciated CHAI and its member institutions for rendering quality healthcare services to the needy and those at the margins of society.

Sr. Jane Wakahiu, Associate Vice President of Programme Operations and Head of Catholic Sisters at the Hilton Foundation, conveyed her pride in the Hilton Foundation's association with CHAI since 2015. She praised the work accomplished by CHAI and its partners, noting that it aligns with and exemplifies the mission to alleviate human suffering. She also emphasized that CHAI and its partners' efforts in accompanying the poor

















reflect the Catholic teachings of social principles and the promotion of human dignity, solidarity, and the preferential option for the poor.

Dr. Ulrich Fuesser, Head of the Asia Department at MISEREOR, congratulated CHAI on its 80th year and mentioned that reaching 80 years carries more power and courage than its earlier years. He praised CHAI for providing quality healthcare and working towards the fulfillment of the right to health for millions of marginalized people in India. Emphasizing the key theme, he mentioned that leadership is crucial for a vast network like CHAI and commented the organization for having a competent and passionate leader like Fr. Mathew Abraham. He also expressed appreciation for the dedicated leaders on the ground, including numerous sister doctors and sister nurses. Dr. Fuesser emphasized the importance of sustainability as CHAI looks towards the future of its mission to build a more resilient healthcare system for future generations and for the benefit of the poor and marginalized.

In his message, Dr. Vikram Mathews, Director of CMC Vellore, addressed the challenging times and pointed out that there is often a tendency to prioritize growth and relevance at any cost. He emphasized the importance of remaining true to the vision and mission, highlighting that true relevance is achieved when the poor and marginalized are at the center and focus of our medical mission.

Fr. Jesudoss, the Director of St. John's Medical College, conveyed his gratitude to CHAI for its commitment and passion in making a positive difference in the lives of many. He stressed the significance of reflecting on the progress achieved thus far and also emphasized the importance of discussing the challenges. He pointed out that together, they have the power to transform lives through their healing ministry.

In her message, Dr. Priya John, MD DNB (Community Medicine) and General Secretary of CMAI,

emphasized the significance of various relevant areas such as disability, palliative care, and numerous community development projects within the CHAI network that have made a meaningful difference to communities. She pointed out that as CMAI and CHAI are partners in a Christian coalition, they contribute significantly to healthcare in the country, and together, they can continue to make a significant difference.

Sr. Dr. Blanch Ancintha Rosario, President of the Sister Doctors Forum of India, emphasized in her message the need to recommit to primary health-care while keeping the objective of 'Health for All' alive. She mentioned that the chosen theme for this AGBM is apt, as it serves as a reminder to every healthcare worker that our ministry of assisting and reaching out to the sick requires visionary skills, dynamic leadership styles, practical and measurable project goals, along with creative motivations to inspire and be inspired.



Sr. Sarla Macwan, National President of CNGI, began her message by expressing appreciation for the services provided by Catholic healthcare facilities. She also addressed the challenges faced by caregivers and institutions, expressing optimism regarding the mentorship role of CHAI. She emphasized how CHAI brings renewed energy to committed and confident healthcare individuals and institutions.

#### **BUSINESS SESSION**

The business session commenced at 2:00 PM. Sr. Victoria Narichiti JMJ, President of CHAI, initiated the session.

The Minutes of 79th AGBM which was read out by Fr. George Kannanthanam CHF, Secretary, CHAI.

#### **Annual Report 2023**

Fr. Mathew Abraham C. Ss. R. Director General shared the Annual Report 2023 highlighting the activities of CHAI.











#### **Audited Statement and Annual Budget**

Sr Bhavya Scaria, CHF, Treasurer, presented the Audited Statement of Account for the year 2022-2023. She also presented the Budget for the Year 2023 -2024.

#### Regional Units' Reports

It was followed by video presentation of the Regional Report from CHAAP, CHABIJAN, CHAKA, CHAKE, CHAMP, CHAT, CHAW, NECHA, OCHA, RUPCHA and WBCHA.

#### Succession Planning for CHAI Directorate

The next agenda was on Succession Planning for CHAI Directorate, conducted by Fr. George Kannanthanam CMF, Secretary of CHAI. The members actively participated in the discussion, with differing opinions. The AGBM decided to promote women leadership. CHAI being a predominantly women's organization, the next DG could be a sister.



# Stories from the Field



## The Story of Meeshal's Transformation

In the tribal hamlet of Lova of Andhra Pradesh, lives a young boy named Meeshal. His journey is one of resilience and transformation, marked by the kindness and dedication of compassionate sisters of Holy Cross.

When Meeshal was just five years old, the Sisters of the Holy Cross Convent in Makkuva discovered him during one of their routine home visits. These sisters, known for their tireless community service, were struck by Meeshal's noticeable bone deformity. With a keen sense of responsibility, they decided to study deeper into his situation.

Through conversations with his father, the sisters learned that Meeshal was a semi-orphan. He had lost his mother at the age of three and was being raised by his father under challenging financial circumstances. Financial hardship had prevented his father from enrolling him in school, and the boy spent his days at home, unable to play or walk like other children his age. Meeshal's father recounted an incident that had changed his son's life. Meeshal had suffered a fall that went untreated, leading to the bone deformity that now plagued him. Despite his father's best efforts to seek medical help, Meeshal's condition did not improve. The boy remained weak, and his health continued to decline.

Recognizing the urgency of the situation, the sisters persuaded Meeshal's father to allow them to take the boy to a hospital. They brought Meeshal to King George Hospital in Visakhapatnam, where he was diagnosed with Bone Tuberculosis (TB). The treatment was extensive, spanning eight months, but it was the beginning of a new chapter for Meeshal.

The Sisters of the Holy Cross didn't stop there. Understanding that a proper education was crucial for Meeshal's future, they convinced his father to enroll him in the Holy Cross Hostel, a facility run by the convent. This arrangement ensured that Meeshal could attend school and receive the care he needed. Today, at ten years old, Meeshal is a different boy. His health has significantly improved, thanks to the dedicated medical treatment and the nurturing environment provided by the sisters. He attends school regularly, actively participates in his studies, and enjoys playing with his friends. The transformation in his life is a testament to the power of compassion and the profound impact that dedicated individuals can have on the lives of those in need.

Meeshal's story is an inspiration of hope, illustrating how timely intervention, medical care, and educational support can transform lives, even in the most challenging circumstances.



The Impact of Community Action:

#### Peddapenki Village

In 2020, Peddapenki, a small remote village in Andhra Pradesh faced a severe health crisis. An outbreak of mosquito borne diseases like malaria, dengue and filariasis spread rapidly through the community, causing widespread panic and fear among the villagers. The root cause of this epidemic was the breeding places of mosquitoes.

Amid the chaos of the epidemic, the sisters of the Holy Spirit, along with some dedicated Community Health Volunteers, stepped in to provide much-needed guidance and support and conducted continuous Health Awareness campaigns. Their tireless efforts began to resonate with the villagers, particularly the elders, who realized that forming a sanitation committee could be a powerful step towards combating future health crisis.

With this newfound resolve, the village elders developed a sanitation committee, composed of Auxiliary Nurse Midwife (ANM), the Village Panchayat Secretary, retired teachers, the Village President, and some enthusiastic youth volunteers. The committee swiftly got into action. Every weekend, they meticulously planned and organized programs aimed at cleaning the village, especially the mosquito breeding sites.

The results of these community-driven initiatives were remarkable. The village of Peddapenki witnessed a significant reduction in the incidence of filarial, malarial, and dengue fever in the next years. The collaborative spirit cultivated through these efforts strengthened the community bonds and instilled a lasting commitment in maintaining a healthy living environment. The story of Peddapenki village is a testament to the profound impact of health education, awareness, and the power of community action. Thanks to the persistent efforts of the sisters of the Holy Spirit, the village elders, and the sanitation committee.

# The Story of Komal's Resilience Amid HIV and Loss

Komal's father, a store assistant in Mumbai became gravely ill and was found HIV positive in 2011. Following testing, Komal and her mother were also found HIV positive. Komal was barely 5 years old when she was tested positive. After their HIV status was known, Komal and her parents were mistreated and discriminated by her joint family members and her father passed away within 6 months.

In 2016, Sister Britto of Holy Cross congregation, one of the implementing partners of CHAI, met Komal and her mother during one of her routine home visits. Komal's uncle had transferred all of the family's property to his name. Sr Britto, her staff, and the Positive People's Network helped them reclaim what they owned. Thereafter Komal was assisted to complete her tenth grade education, enrolling at Snehadeep Holy Cross School.

In 2020, Komal lost her mother. However, in the midst of overwhelming obstacles, Komal persisted in striving for a brighter future. CHAI's digital training program advanced her skill development. Following the digital training, she obtained beautician skills and is currently employed in Ranchi, where she earns Rs. 12,000 per month. She has discovered a life of dignity and self-sufficiency in spite of the difficulties posed by her HIV diagnosis and social shame.

"Life has been tough, but with the support I received, I found the strength to keep going. Today, I am proud of what I have achieved" says Komal.

Abhishek's Story:




Abhishekh Malka, a 7-year-old boy from Ballarpur, Maharashtra, has faced significant challenges from a very young age. Born into a poor family, Abhishekh has both his upper and lower limbs affected, severely limiting his mobility. Despite their hard work, Abhishekh's parents struggle to meet the family's daily needs, let alone provide the additional resources required for his treatment and support.

Before receiving proper therapy and support, Abhishekh relied on a wall to stand. He needed additional support for both knees to keep his legs straight. Understanding their dire situation, Sr. Viviyana Paskal from the Dilasagaram Society, one of the implementing partners of CHAI, reached out to Abhishekh and his family. The sisters provided physiotherapy, ADL training, and a knee splint.

With the support of the sisters, Abhishekh's parents were able to give him regular gait training, which has significantly reduced his muscle stiffness. Abhishekh is now able to move with greater ease and independence, bringing immense joy for him and his family.

Abhishekh's story is one of resilience and transformation, demonstrating the profound impact of community support and proper rehabilitation. His journey from immobility to independence is an inspiration to all.



# Ansari Family: Overcoming TB through Treatment Adherence

On December 20, 2022, the CHAI coordinator visited Ashma Ansari's home to counsel them about Tuberculosis Preventive Therapy (T.P.T) medication. The Ansari family consisted of five members. After the visit, they met with the medical officer of Sadar TU and began the T.P.T medication following an assessment.

However, when the coordinator visited their home a month later, no one had been taking the T.P.T drugs. The coordinator counselled them that the medication was crucial for protecting their family from tuberculosis the importance of taking it regularly. On February 12, 2023, it was observed that the family had indeed started taking the medication and had kept the empty strips as proof. It showed that the family had understood the importance of T.P.T drugs and had overcome the stigma against government-provided medication.

Typically, impoverished families opt to consult local quack practitioners, but the Ansari family completed their T.P.T treatment and finished the medication on June 26, 2023. Today, they are all in good health. The story of Ansari family, highlights the impact of persistence and education in overcoming health challenges and misconceptions.

## Matha Vihar Hospital: From Blackouts to Solar Power



Matha Vihar is a 15-bedded hospital located in a remote part of Maharashtra's Shengaon region. The hospital began as a dispensary in 2002 and now serves about 50 villages in its vicinity. Matha Vihar also provides health awareness and education support for young girls, doubling up as a social change enabler in the region. But it faces about six hours of power cuts every day, affecting the hospital's efforts to provide timely, quality healthcare

With many cement factories in our neighbourhood, they receive several patients with breathing difficulties due to the dust and air pollution. They have oxygen cylinders and nebulizers, but cannot treat patients because of power cuts and voltage fluctuations. Most time, they were forced to refer patients to other facilities.

To address the power cuts, Matha Vihar recently installed a Solar PV System with a peak capacity of 10 kilowatts (kWp) with support from CHAI and WRI India. Now with reliable power from the Solar PV System and battery backup, Matha Vihar has been admitting patients at nights as well, something, they could not do earlier. They can provide red-light therapy treatment for back pain, can perform the doppler testing for pregnant women. They can provide nebulizer and oxygen support as well.

Previously, they had a smaller (solar) plant. But now they have a bigger plant with more panels, and it comes with battery backup and Remote Monitoring System (RMS), where the performance of the solar panels can be monitored on phones.

Sr Joicy, the administrator mentioned that they had a tough time retaining doctors. Due to unregulated power cuts, they don't wish to stay here. Doctors usually say, "We are ok with less pay, but the heat is too much to bear without electricity." With solar power, they are able to retain doctors as well.



#### **REGIONAL UNITS REPORT**

CHAI is a network organization and has 3,603 Member Institutions (MIs) in the network. These Member Institutions (MIs) vary in size and service and includes large hospitals, health centres, small hospitals (with less than 50 beds capacity), social service societies, College of Nursing etc. Vast majority of these MIs are located in rural and even difficult-to-reach areas; and some are in urban areas too. In order to have effective coordination and representation, the MIs are aggregated to 11 Regional Units (RUs). Each of this Regional Unit is a separate entity registered under Societies Registration Act in their respective states. Besides, providing coordination support to the MIs by organizing periodic meetings, workshops and training for capacity strengthening, the RUs also implement programmes with financial support from various organizations including the government. This section briefly describes the MIs associated with and the projects and special events implemented directly by the Regional Units.

1. The project 'Integrated Approach to Community Empowerment & Health' is implemented in Jahangirpuri, Delhi, led by Jivodaya Dispensary. The project focuses on empowering slum dwellers, particularly targeting women, youth and children.





- 2. The central procurement system is one of the platforms RUPCHA has created to centralize all the purchases of our hospitals. This involves signing the rate agreement with companies at RUPCHA central level and fixing a single rate for each product for all the hospitals. Presently 54 Member hospitals with 10-400 bed strength are involved covering 7 States & 3 UTs of Northern India.
- **3. Mainstreaming the School Dropouts project** is aimed to reintegrate school dropout children, especially girls as well as support the underprivileged school going children from the locality to continue their education and their overall development. It is implemented by The Holy Cross Community Centre, Jeeva Jyothi Social Service Centre and CHF Health centers. Through this program 240 children were supported.
- **4.** The project **'Dil Hei Beti Ki Aasha Light the Hope Candle'** is funded by the Young Presidents Organization and implemented by Sparsh Health Centre. Its primary aim is to assist underprivileged school dropouts and school-going girls in Burari Village, Delhi ensuring their education, nutrition and overall development.







- **5. Gyandhara Child Development Program** receives funding from Light the Candle International Inc., California and is implemented by Jivan Dhara Welfare Centre. This program focuses on supporting the school dropouts and underprivileged school-going girls to continue their studies and their overall development (Educational, Physical, Nutritional, Social, Mental, Moral values). 50 children were being benefited.
- **6.** An Emergency Support for Delhi Flood Victims residing on the banks of river Yamuna. 142 families received support to restore their lives to normal. This support was provided by RUPCHA in collaboration with its member institutions.

We have audited the accompanying financial statements of Catholic Health Association of India, which comprise the Balance Sheet as at March 31, 2024, and the Income & Expenditure Account for theyear then ended.

Management is responsible for the preparation of these financial statements that give a true and fair view of the financial position and financial performance. This responsibility includes the design, implementation and maintenance of internal control relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.
